I have known Karen Mahlo for some time and have been treating her for a significant psychiatric problem. I am aware that she recently had a massive overdose of medication, which resulted in her admission to a clinic in New Farm. I have had two recent visits from Karen, one of which and the most recent of such was in the presence of her father. I am aware that she has made at least two attempts on her life. Six to eight weeks ago she had a very large overdose. Previously she has cut her wrists and nearly blead to death. She has a significant drinking problem and as a result exhibited behavioural difficulties and was irrational. On the 23rd May 2007 she cut her right wrist. In April of 2007 she took pills and cut herself, slicing a large artery in her ankle. I am aware that Karen has been experiencing difficulties with the Medical fraternity involving her work at the Nambour Hospital and there has been involvement with Redcliffe Health and I believe that there may have been some communication indicating her return to work. I last saw the deceased on the 21st May 2008. I beleive Karen last communicated with the hospital on the 23rd May 2008. I understand Karen and her partner John had recently split up. I understand that John has been supportive of Karen and I am unaware of any recent conflict between them. Any conflict often appeas to have resulted from excessive alcohol consumption by Karen. I believe that Karen last communicated with my secretary and indicated that she had recently communicated with Senior Medical management and that the communication according to Karen had been positive.
